

ABOUT THE MISSION

Piedmonte Agency for Investment, Export and Tourism (CEIP) and The Indo Italian Chamber of Commerce and Industry (IICCI), in collaboration with the European Business and Technology Centre (EBTC) in India, will organize a business mission of European companies dedicated to "Renewables & Energy Efficiency and Technologies for Environment Protection from 21-25 September 2015 in the cities of Mumbai, Delhi and Bangalore.

WHY PARTICIPATE | SECTORS HIGHLIGHTED

India has an outstanding potential to develop its energy market, both in terms of customer basin and of abundance in green energy sources such as wind, hydro, biomass and solar. It is the 3rd largest producer and the 4th largest consumer of electricity in the world. Government planned investments for 198.8 billion EUR, aiming to add 88.5 GW by 2017. It is still heavily dependent on fossil sources. Nevertheless 30 GW of green energy generation capacity has been added since 2007.

India is facing a number of environmental challenges due to increasing urbanization, industrialization, deforestation, transportation, high intensity agriculture and population migration. A renewed attention to environmental issues is given by the Indian Government national campaign "Swachh Bharat Mission" (Clean India Mission)". Key environmental issues requiring technology inputs and solutions are identified in: Solid Waste and Land Degradation; Water management and pollution control; Air pollution.

A mapping of the needs and demands of Cleantech solutions in India in the energy and in the environmental field has been carried out highlighting specific demand in the different segments of power generation and distribution, energy management, energy efficiency and saving, remote and rural electrification as well as water and waste management, air and soil protection and the related sub-sectors.
